AN ACT to appropriate \$783,394,935 dollars to the service of the State of Grenada for the period January 01 to December 31, 2011.

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives, and by the authority of the same as follows—

PART I

PRELIMINARY

Short Title and commencement.

1. This Act may be cited as the

APPROPRIATION ACT, 2011.

Appropriation.

2.—(1) There may be issued from the Consolidated Fund and applied to the service of the State of Grenada for the

period January 01 to December 31, 2011, a sum not exceeding Seven hundred and eighty-three million, three hundred and ninety-four thousand, nine hundred and thirty-five dollars.

(2) The sum mentioned in subsection (1) is appropriated for the purposes specified in the Schedule.
