## STATUTORY RULES AND ORDERS NO. 10 OF 2011

The Minister in exercise of the powers conferred on him by Section 5 of the Statistics  $Act\ Cap.\ 311\ makes\ the\ following\ Order-$

1. Citation. This Order may be cited as the

## STATISTICS (CENSUS) ORDER, 2011.

- **2. Definition.** In this Order—
  - "Census night" means from 6:00 p.m. on 12th May 2011 to 6:00 a.m. on 13th May 2011;
  - "householder" means the person designated by the occupants of a private dwelling to provide information for purposes of the census;
  - "West Indies" means the Commonwealth Territories and all Dutch, French and United States possessions and former possessions lying between the Equator and the Tropic of Cancer, and between the 50th and 90th meridian of longitude West of Greenwich together with the countries of Cuba, the Dominican Republic, Haiti, Guyana and Venezuela.
- ${\bf 3.\, Dates\, of\, Census.}$  A Census for the whole of the States shall be taken on 12th May 2011.
- **4. Information to be obtained.** (1) Information for the purpose of the Census shall be obtained with respect to all persons who are alive at midnight on Census night, and who pass Census night
  - (i) at any place on land within the State;
  - (ii) on any vessel, not being a ship registered in a port outside the West Indies, within the territorial waters of the State;
  - (iii) on any vessel, not being a ship registered in a port outside the West Indies, which is due to arrive in the State within 5 days following 12th May 2011, without having called at any Commonwealth Caribbean port since midnight on Census night.

- (2) Information for the purpose of the Census with respect to the persons described in sub-paragraph (1) of this paragraph shall be obtained from
  - (a) the householder of every private dwelling or any adult in the dwelling with respect to all persons who pass Census night on the premises of that dwelling;
  - (b) the proprietor or manager of every hotel, boarding school, boarding house, orphanage, hotel or other similar institution or any person authorized by such proprietor or manager, with respect to all persons who pass Census night on the premises of that institution;
  - (c) the chief resident officer of every public or private hospital, nursing home, almshouse, homes for aged or other institution, with respect to all persons who pass Census night on the premises of the hospital or other institution;
  - (d) the Commissioner of Prisons and the officer in charge of every lockup (including the prison cells at Hillsborough on the island of Carriacou) with respect to all persons who pass Census night on the premises of a prison or lock-up;
  - (e) the master of every vessel described in sub-paragraphs (ii) and (iii) of paragraph (1) with respect to all persons who pass Census night aboard such ship or boat.
- **5. Particulars to be stated.** The particulars to be stated in the Census returns are those set out in the Schedule to this Order.

## **SCHEDULE**

- **1. Listing of Household Members** The names of all persons who usually live and share one daily meal in the household starting with the head.
- 2. Housing In respect of a dwelling type of building and dwelling, type of tenure, type of land occupancy, material of outer walls, material used for roofing, year when built, water supply, toilet facilities, type of lighting, fuel for cooking, type of kitchen, number of rooms and bedrooms, other facilities available such as radios, TV sets, videos, telephone, etc. and number of motor vehicles.

Also in respect of crime – Whether any person has been a victim of crime, nature of crime, whether crime was reported. Also, in respect of death – Whether any member of the household died in the past year.

- **3. Migration** Whether any person has moved to live abroad, year moved, educational status, gender, age and occupation when moved and country of migration.
- **4. Personal Characteristics** In respect of every person Relationship to head of household (where relevant), gender, date of birth, age, ethnic group and religion.
- **5. Birthplace and Residence** In respect of every person Birthplace, place last lived, place of normal residence, years of residence in that place.
- **6. Disability** Whether any person suffers from disability or impairment or long-standing illness, type of disability, whether disability limits activity and if so which activity.
- **7. Health** In respect of every person Utilization of medical facilities, whether insurance coverage or medical plan, type of insurance.
- **8.** Education and Internet access In respect of every person type of school or institution now being attended, previous attendance at school or institution, highest level of education attained, mode of travel to school or institution, highest examination passed.

Whether or not internet access is available for household and type of internet access.

- **9. Professional, Technical and Vocational Training** Occupation for which trained, method by which training acquired, period of training, field of highest level of training.
- 10. Economic Activities In respect of every person of 15 years and over Main activity during past 12 months, worker or occupational status during the past 12 months, months worked during the past 12 months, main activity during the past week, number of hours worked during the past week, kind of work looked for, type of business activity, name and address of business place, mode of travel to work, time taken to get to work, gross pay or income received from family abroad during the last year and hours worked per week on housework.

  - **11. Income and Livelihood** In respect of every person of 15 years and over frequency of income payment, gross salary, main source of livelihood, remittances from abroad.
  - **12. Marital or Union Status** In respect of every person of 15 years and over Legal marital status or union status, duration of marriage or union.
  - 13. Fertility In respect of every person of 15 years and over Number of live births ever had, age of mother at birth of first child born alive, age of mother at birth of last child born alive, number of live births during the last 12 months, sex of children, death that occurred to births during the last 12 months.
  - **14. Location** In respect of every person Where did he or she spend Census night?
