STATUTORY RULES AND ORDERS NO. 16 OF 2012

THE MINISTER IN EXERCISE OF THE POWERS CONFERRED ON HIM BY SECTION 11 OF THE POWER - CRAFT ACT CAP. 249 OF THE 2010 CONTINUOUS REVISED EDITION OF THE LAWS OF GRENADA MAKES THE FOLLOWING REGULATIONS—

(Gazetted 11th May, 2012).

**1. Citation.** These Regulations may be cited as the

POWER CRAFT (LICENSING) (AMENDMENT) REGULATIONS, 2012

and shall be read as one with the Power Craft (Licensing) Regulations CAP. 249 Subsidiary Legislation of the 2010 Continuous Revised Edition of the Laws of Grenada hereinafter referred to as the “principal Regulations.”

**2. Amendment of Second Schedule.** The Second Schedule to the principal Regulations is repealed and substituted with the following new Schedule;

1. Licence fees for Passenger Carrying Craft (commercial)

Passenger carrying capacity of 2–10 persons	\$290.00
Passenger carrying capacity of 11–15 persons	\$485.00
Passenger carrying capacity of 16–25 persons	\$725.00
Passenger carrying capacity of 26–50 persons	\$960.00
Passenger carrying capacity of 51 and over	\$1,950.00

2. Licence fees for Passenger Carrying Craft (non-commercial)

Passenger carrying capacity of 2–10 persons	\$150.00
