STATUTORY RULES AND ORDERS NO. 18 OF 2021

THE MINISTER IN EXERCISE OF THE POWERS CONFERRED ON HIM BY SECTION 52 OF THE FIREARMS ACT, CHAPTER 105 HEREBY MAKES THE FOLLOWING REGULATIONS—

(Gazetted 30th April, 2021).

1. Citation. These Regulations may be cited as the

FIREARMS (AMENDMENT) REGULATIONS, 2021,

and shall be read as one with the Firearms Regulations, Chapter 105 hereinafter referred to as the “principal Regulations”.

2. Amendment of First Schedule to principal Regulations. The principal Regulations are amended by repealing the First Schedule and substituting therefor the following new schedule—
