STATUTORY RULES AND ORDERS NO. 32 OF 2011

RESOLUTION FOR THE PURPOSES OF SECTION 35 OF THE PUBLIC FINANCE MANAGEMENT ACT NO. 27 OF 2007.

(Gazetted 11th November, 2011).

WHEREAS it is provided by section 35(1) of the Public Finance Management Act, (hereinafter referred to as “the Act”) that the Minister of Finance may, with the approval of Parliament, by means of a reallocation warrant under his hand, direct the Accountant General that savings arising from an expenditure vote contained in the annual or supplementary estimates, approved by an Appropriation Act or a Supplementary Appropriation Act, be applied in aid of any item in any other expenditure vote, in those estimates or in aid of any new programme of expenditure and the amounts to be applied shall be deemed to have been appropriated for that purpose;

WHEREAS it is further provided by section 35(2) of the Act, that no reallocation warrant shall be permitted where it concerns the reallocation of personal emoluments in an expenditure vote, unless it involves personal emoluments within another expenditure vote, nor shall any reallocation occur between recurrent and capital expenditures;

AND WHEREAS it is expedient that the Minister of Finance be authorized to direct the Accountant General to reallocate budgetary allocations from the Ministry of Labour to the Ministry of Works, Physical Development and Public Utilities, from the Ministry of Legal Affairs to the Ministry of Works, Physical Development and Public Utilities, and from the Ministry of Education and Human Resource Development to the Ministry of Social Development;

NOW THEREFORE BE IT RESOLVED that pursuant to the provisions of section 35 of the Act, the Minister of Finance be authorized to direct the Accountant General to reallocate budgetary allocations from the Ministry of Labour to the Ministry of Works, Physical Development and Public Utilities, from the Ministry of Legal Affairs to the Ministry of Works, Physical Development and Public Utilities, and from the Ministry of Education and Human Resource Development to the Ministry of Social Development, as set out in Schedule I and the total reallocation is set out in Schedule II.
