AN ACT to appropriate an additional sum of eighty-six million, seven hundred and sixty-seven thousand, eight hundred and one dollars and thirty-seven cents (\$86,767,801.37) to the service of the State of Grenada for the period July 1st to December 31st, 2017.

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives, and by the authority of the same as follows—

1. This Act may be cited as the

2.—(1) There may be issued from the Consolidated Fund and applied to the service of the State of Grenada for the period July 1st to December 31st 2017, a sum not

exceeding eighty-six million, seven hundred and sixty-seven thousand, eight hundred and one dollars and thirty-seven cents (\$86,767,801.37) in addition to the sums already appropriated for that year.

(2) The sum mentioned in subsection (1) is appropriated for the purposes specified in the Schedule.
