AN ACT to appropriate an additional sum of \$31,099,922.15 to the service of the State of Grenada for the period November 1st to December 31st 2013.

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives of Grenada and by the authority of the same as follows—

2.—(1) There may be issued from the Consolidated Fund and applied to the service of the State of Grenada for the period November 1st to December 31st 2013, a sum not
