AN ACT to appropriate an additional sum of forty million, thirty-three thousand, ninety-seven dollars and sixty-nine cents (\$40,033,097.69) to the service of the State of Grenada for the period October 1st to December 31st, 2014.

BE IT ENACTED by the Queen's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives, and by the authority of the same as follows—
