STATUTORY RULES AND ORDERS NO. 12 OF 2017

THE MINISTER IN EXERCISE OF THE POWERS CONFERRED ON HER BY SECTION 37 OF THE SPICEMAS CORPORATION ACT, 10 OF 2011 HEREBY MAKES THE FOLLOWING REGULATIONS—

(Gazetted 2nd June, 2017).

1. Citation. These Regulations may be cited as the

SPICEMAS CORPORATION (CARNIVAL FESTIVAL
LICENCES) REGULATIONS, 2017.

2. Definitions. (1) In these Regulations—

“Act” means the Spicemas Corporation Act No. 10 of 2011;

“Applicant” means a person who makes an application for a carnival festival licence;

“carnival festival licence” means a licence granted under section 6 of the Act;

“Licence Holder” means a person to which a carnival festival licence has been granted.

(2) Words and expressions used in the Regulations and which are also used in the Act shall, unless the context otherwise requires have the same meaning as assigned to it in the Act.

3. Application form for carnival festival licence. An application for a carnival festival licence shall be in the form as set out in Form I in Schedule I of these Regulations.

4. Forms for carnival festival licence. (1) Subject to subregulations (2) and (3), a carnival festival licence shall be in the form as set out in Form II in Schedule I of these Regulations.

(2) In the case of a carnival festival licence granted to hold a carnival festival or activity for which an admission fee would be charged, the carnival festival licence shall be in the form as set out in Form III in Schedule I of these Regulations.

(3) In the case of a carnival festival licence granted to a person resident outside of Grenada, the carnival festival licence shall be in the form as set out in Form IV in Schedule I of these Regulations.

5. Returns for a carnival festival or activity with admission fee. Returns for a carnival festival licence granted for a carnival festival or activity for which an admission fee would be charged shall be in the form as set out in Form V in Schedule I of these Regulations.

6. Application form for appeal to Minister. An application for an appeal to the Minister against the decision of the Board, under section 6A (1), shall be in the form as set out in Form I in Schedule II of these Regulations.

7. Application form for appeal to Tribunal. An application for an appeal to the Tribunal against the decision of the Minister, under section 6A (3), shall be in the form as set out in Form II in Schedule II of these Regulations.

8. Fees. (1) The fees in respect of the following—

- (a) an application for a carnival licence as provided under section 6 (2) of the Act;
- (b) an application for an appeal to the Minister against the decision of the Board, under section 6A (1);
- (c) an application for an appeal to the Tribunal against the decision of the Minister, under section 6A (3),

shall be the fees as set out in Schedule III of these Regulations.

(2) Without prejudice to section 6 (3) of the Act, in the case of a carnival festival or activity that does not qualify under section 6 (4) of the Act, the Corporation may attach as a condition to the licence granted that no later than seven days after the conclusion of the carnival festival or activity, the holder of the licence shall pay to the Corporation—

- (a) in the case of attendance of less than 1,000 individuals at the carnival festival or activity, a fee of \$250.00;
- (b) in the case of attendance of not less than 1,000 individuals at the carnival festival or activity, a fee of \$500.00.
