STATUTORY RULES AND ORDERS NO. 13 OF 2019

THE MINISTER IN EXERCISE OF THE POWERS CONFERRED ON HIM BY SECTION 16 OF THE GRENADA CITIZENSHIP BY INVESTMENT ACT NO. 15 OF 2013, MAKES THE FOLLOWING REGULATIONS—

(Gazetted 24th May, 2019).

**1. Citation.**—(1) These Regulations may be cited as the

GRENADA CITIZENSHIP BY INVESTMENT (AMENDMENT)  
(NO. 3) REGULATIONS, 2019.

and shall be read as one with the Grenada Citizenship by Investment Regulations, 2013 SRO No.17 of 2013, hereinafter referred to as the “principal Regulations”.

(2) These Regulations shall come into force on the 24th day of May, 2019.

**2. Amendment to Schedule I.** Schedule I of the principal Regulations is amended by repealing the table headed “Qualifying investment for approved project applicant, government fees for significant Investment Applicant and Applicants participating in the National Transformation Fund” and substituting therefor the following—
