STATUTORY RULES AND ORDERS NO. 17 OF 2017

THE GOVERNOR-GENERAL IN EXERCISE OF THE POWERS CONFERRED ON HER BY SECTION 52 OF THE MARRIAGE ACT CAP. 184, MAKES THE FOLLOWING REGULATIONS—

(Gazetted 21st July, 2017).

1. Citation. These Regulations may be cited as the

MARRIAGE (SPECIAL LICENCES–DESTINATION WEDDING) (AMEND-
MENT) REGULATIONS, 2017.

and shall be read as one with the Marriage (Special Licences–Destination Wedding) Regulations No. 12 of 2013, hereinafter referred to as the “principal Regulations” .

2. Amendment of Regulation 4 of the principal Regulations. Regulation 4 of the principal Regulations is amended in sub-regulation (1) by deleting the words “valid for a period of five years” and substituting therefor “valid for the period stated in the licence”.

2. Amendment to Regulation 7 of the principal Regulations. Sub-section (1) of regulation 7 of the principal Regulations is repealed and the following substituted therefor—

“The Governor-General may in accordance with these Regulations grant a special Licence in Form IV of Schedule I for the marriage of persons in Grenada.”.

3. Amendment of Regulation 12 of the principal Regulations. Regulation 12 of the principal Regulations is amended in sub-regulation (1) by deleting the words “before the period of residency referred to in regulation 7” and substituting therefor “before the date of the intended marriage”.

4. Amendment of Regulation 13 of the principal Regulations. Regulation 13 of the principal Regulations is amended as follows—

- (i) by deleting the words “and shall take effect twenty-four hours after the actual time of residence”; and
- (ii) by inserting a “full stop” after the words “regulation 11”.

5. Amendment of Schedule II of the principal Regulations. Schedule II of the principal Regulations is amended by repealing the words-

“Agent licence fee	EC\$7500.00	(Regulation 2)
Agent licence renewal fee	EC\$7500.00	(Regulation 2)
Special Marriage Licence fee	EC\$ 500.00	(Regulation 2)”

where they appear and substituting therefor-

“(Regulation 4(2))

Agent licence fees (*payable upon grant of licence*)

EC \$1,500.00 for one year
EC \$2,500.00 for two years
EC \$4,000.00 for three years
EC \$7,500.00 for five years

Agent licence renewal fee

EC \$1,500.00 for one year
EC \$2,500.00 for two years
EG \$4,000.00 for three years
EC \$7,500.00 for five years

Special Marriage Licence fee EC\$ 500.00 (*Regulation 7(2))”*
