### STATUTORY RULES AND ORDERS NO. 2 OF 2020

THE NATIONAL WATER AND SEWERAGE AUTHORITY WITH THE APPROVAL OF THE MINISTER IN EXERCISE OF THE POWERS CONFERRED ON IT PURSUANT TO SECTION 52 (1) OF THE NATIONAL WATER AND SEWERAGE AUTHORITY ACT CAP. 208, HEREBY MAKES THE FOLLOWING REGULATIONS—

(Gazetted 31st January, 2020).

1. Citation. These Regulations may be cited as the—

## WATER AND SEWERAGE RATES AND CHARGES (AMENDMENT) REGULATIONS, 2020.

- **2.** Commencement.—(1) Subject to subregulation (2), these Regulations shall come into force on the 1st day of February, 2020.
- (2) With respect to cruise ships, these Regulations shall come into force on the 1st day of October, 2020.
  - **3. Definitions.** In these Regulations—
    - "cruise ship" shall have the meaning assigned to it under the Cruise Ship (Visitors Levy) Act Cap. 74B;
    - "principal Regulations" means the Water and Sewerage Rates and Charges Regulations Cap. 208.
- **4. Amendment of regulation 3 of principal Regulations.** Regulation 3 of the principal Regulations is repealed and the following substituted therefor—
  - **3. "Rates, charges and fees payable by metered consumers.—**(1) The rates, charges and fees for the supply of water by the Authority shall be as set out in the First Schedule.
  - (2) The fixed monthly charge for non-domestic consumers shall be calculated using the average monthly consumption of the owner over the previous calendar year (or part thereof) and shall be reviewed at the end of each year.".

- **5. Amendment of regulation 6 of principal Regulations.** Regulation 6 of the principal Regulations is amended as follows—
  - (a) in subregulation (2)–
    - (i) by deleting the word "charge" and substituting therefor the word "deposit"; and
    - (ii) by deleting the words "Part B of the Second Schedule" and substituting therefor the words "the First Schedule"; and
  - (b) in subregulation (3), by deleting the word "charge" and substituting therefor the word "deposit".
- **6. Amendment of First Schedule to principal Regulations.** The principal Regulations are amended by repealing the First Schedule and substituting therefor the following new schedule—
