STATUTORY RULES AND ORDERS NO. 3 OF 2017

IN ACCORDANCE WITH SECTION 103 (2) OF THE WEST INDIES ASSOCIATED STATES SUPREME COURT (GRENADA) ACT CAP. 336, THE CHIEF JUSTICE AND TWO OTHER JUDGES OF THE SUPREME COURT BEING THE AUTHORITY EMPOWERED BY SECTION 17 OF THE WEST INDIES ASSOCIATED STATES SUPREME COURT ORDER 1967 TO MAKE RULES REGULATING THE PRACTICE AND PROCEDURE OF THE COURT OF APPEAL AND THE HIGH COURT HEREBY MAKE THE FOLLOWING RULES—

1. Citation and Commencement. (1) These Rules may be cited as the

EASTERN CARIBBEAN SUPREME COURT (SITTINGS OF THE
COURT) (AMENDMENT) RULES, 2017.

(2) These Rules shall come into effect on the 1st day of April, 2017.

2. Interpretation. In these Rules the “principal Rules” means the Eastern Caribbean Supreme Court (Sittings of the Court) Rules, 2014, S.R.O. No. 41 of 2014.

3. Amendment of rule 4. Rule 4 of the principal Rules is amended by deleting subrule (2) and substituting the following—

“(2) Subrule (1) shall not apply to Anguilla, Montserrat and the Nevis Circuit of Saint Christopher and Nevis.”.

4. Amendment of rule 5. Rule 5 of the principal Rules is amended by deleting—

(a) the heading and substituting the following—

“Sittings of the High Court in Anguilla, Montserrat and Nevis”

(b) subrules (1)(c) and (d) and substituting the following—

“(c) In Nevis on the first Tuesday of the months of April and November,”.
