STATUTORY RULES AND ORDERS NO. 68 OF 2016

THE MINISTER RESPONSIBLE FOR MATTERS RELATING TO CITIZENSHIP IN THE EXERCISE OF POWERS CONFERRED ON HIM PURSUANT TO SECTION 5A OF CITIZENSHIP ACT CAP. 54 MAKES THE FOLLOWING REGULATIONS—

(Gazetted 4th January, 2017).

1. Citation. These Regulations may be cited as the

CITIZENSHIP (AMENDMENT) REGULATIONS, 2016.

2. Interpretation. In these Regulations—

“principal Regulations” means the Grenada Citizenship Regulations Cap. 54.

3. Amendment of the principal Regulations. The principal Regulations is amended as follows—

(a) **Insertion of new regulation in principal Regulations**

The principal Regulations is amended by inserting after regulation 4A the following—

“Application for registration of a descendant of a citizen of Grenada

4B. An application for registration as a citizen of Grenada under section 5A of the Act shall be in the form set out in Part II of the Third Schedule.

Regulation 4B

GRENADA CITIZENSHIP ACT CAP. 54 – SECTION 5A

Application for registration of a person who is a descendant of a citizen of Grenada.

N.B: Portions of this form which are not applicable MUST be struck out and initialed in EVERY case.

CAUTION: To give information on this form, purposely or recklessly is a criminal offence punishable with imprisonment. (*Section 14 Cap. 54*).
