1. Citation. These Regulations may be cited as the

## GRENADA CITIZENSHIP BY INVESTMENT (AMENDMENT) REGULATIONS, 2017,

and shall be read as one with the Grenada Citizenship by Investment Regulations No. 17 of 2013, hereinafter referred to as the "principal Regulations".

**2. Amendment of Schedule II.** Schedule II of the principal regulations is amended by repealing Form VI and substituting the following therefor—
