GRENADA

ACT NO. OF 2021

AN ACT to appropriate a sum of One Billion, Three Hundred and Fifty-two Million, Two Hundred and Ten Thousand, Six Hundred and Thirty-five dollars (\$1,352,210,635.00) to the service of the State of Grenada for the period 1st January to 31st December, 2022.

BE IT ENACTED by the Queen’s Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives, and by the authority of the same as follows—

Short title

1. This Act may be cited as the

APPROPRIATION (2022) ACT, 2021.

Appropriation

2. (1) There may be issued from the Consolidated Fund and applied to the service of the State of Grenada for the period 1st January to 31st December, 2022, One Billion, Three Hundred and Fifty-two Million, Two Hundred and Ten Thousand, Six Hundred and Thirty-five dollars (\$1,352,210,635.00).

- (2) The sum mentioned in subsection (1) is appropriated for the purposes specified in the Schedule.
