**ACT NO. OF 2022**

**AN ACT** to appropriate an additional sum of One Hundred and Ninety-Four Million, Seven Hundred and Two Thousand, Nine Hundred and Ninety-One Dollars Eastern Caribbean Currency (EC\$194,702,991.00) to the service of the State of Grenada for the fiscal year 1st January to 31<sup>st</sup> December 2022.

**BE IT ENACTED** by the King's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives, and by the authority of the same as follows—

**Short title**

1. This Act may be cited as the

**SUPPLEMENTARY APPROPRIATION ACT, 2022.**

**Appropriation**

2. (1) There may be issued from the Consolidated Fund and applied to the service of the State of Grenada for the fiscal year 1st January to 31<sup>st</sup> December 2022, a sum not exceeding One Hundred and Ninety-Four Million, Seven Hundred and Two Thousand, Nine Hundred and Ninety-One Dollars Eastern Caribbean Currency (EC\$ 194,702,991.00) in addition to the sums already appropriated for that fiscal year.

- (2) The sum mentioned in subsection (1) is appropriated for the purposes specified in the Schedule.
