**RESOLUTION FOR THE PURPOSES OF SECTION 56 OF THE PUBLIC FINANCE  
MANAGEMENT ACT NO. 17 OF 2015**

**WHEREAS** section 56 (1) of the Public Finance Management Act No. 17 of 2015 (hereinafter referred to as “the Act”) provides *inter alia* that no money shall be raised on the credit of the Government of Grenada except under the authority of this Act or under an Act of Parliament or a Resolution of the House of Representatives;

**WHEREAS** section 56 (2) of the Act provides *inter alia* that the Minister of Finance may borrow when authorised by Resolution of the House of Representatives money on behalf of the Government of Grenada in any form and from any legitimate source on terms and conditions to be agreed with the creditor;

**WHEREAS** it is further provided that the amount shall not exceed in the aggregate the sum specified in the Resolution;

**AND WHEREAS** it is expedient that the Minister of Finance be authorised by a Resolution of the House of Representatives to borrow on behalf of the Government of Grenada, money to an amount not exceeding in the aggregate the sum of Three Hundred and seventy-five Million Eastern Caribbean Dollars (EC\$375,000,000.00) to meet current expenditure requirements;

**NOW THEREFORE BE IT RESOLVED** that the House of Representatives hereby authorises the Minister of Finance to borrow on behalf of the Government of Grenada money to an amount not exceeding in the aggregate the sum of Three Hundred and seventy-five Million Eastern Caribbean Dollars (EC\$375,000,000.00) for the period January 1 to December 31, 2024.
