## **ANNOUNCEMENTS BY MADAM PRESIDENT**

### *Madam President made the following announcements:*

“Ladies and gentlemen, again a pleasant and warm, and a little rainy we hope, Grenadian good morning. Since we last met a month ago, less than a month ago, I’ve been able to, I’ve been... I’ve attended the Fourth (4<sup>th</sup>) International Conference on Small island Developing States. I would like to report that there was a, a... it was an important meeting because it was the fourth (4<sup>th</sup>) occasion on which the world gathered to consider the vulnerability of small island developing states, and to further develop their resilience, as partners.

The Grenada delegation was led by our Prime Minister, Honourable Dickon Mitchell and our two (2) other Ministers, our very own Senator Gloria Thomas and from the “Other Place”, Senator Kerryne James. We were also accompanied by the Permanent Secretary in the Ministry of Resilience, Climate Resilience, His Excellency the Ambassador Phillip Ché out of the Permanent Mission of Grenada to the United Nations, several other technical experts and observers.

And I think the interesting thing for... one (1) of the interesting things was to see the young persons on the delegation. We had a number of young people, one (1) was specifically designated for the Youth Summit, another one was designated for the Civil Society Summit and we also met a number of Grenadians there. I was quite pleased to see Halim Brizan who came to represent CARICOM, Eudine Barribeau, Professor Emerita .... Sorry to be calling names Hazel Da Breo, Child Phycologist and many other Grenadians. We met Grenadians in Antigua as well.

So I would say that for Grenada as a Small Island Developing State, we had the opportunity to participate in the three (3) levels of the conference. The first one (1) was the Civil Society Summit which went on for two (2) days. It was led by the Caribbean Civil Society Organization, CANARI as well as some other groups, the environmental organizations. And there must have been representation from the Maroons people of the Caribbean as indigenous people, women’s activist, environmental activists and several others. And they did issue a statement, the Caribbean we want.

I would encourage you to take a look at it, it lays out a vision for the management of the environment, the ecosystems, biodiversity, conservation and how it relates in particular to community. The second two (2) days was a summit, the Gender Equality Forum, which was led by the United Nations Women, but supported by ParlAmericas and other organizations. And there were about 250 women from, really around the world, if I remember correctly. Senator Thomas was one of the prominent Ministers from the Caribbean participating. I also had the opportunity to meet the president of Dominica. I don’t know how new she is.

I hadn’t known her before, but it was interesting and important and repeated quite a bit, that here we are in the Caribbean, with the first woman President of Dominica. And she’s

also an indigenous woman, the Kalinago. So the Caribbean was making a show of the depth of... the depths to which it goes in its society, to promote or to advance women's leadership. That meeting, that two (2) day meeting also issued a statement which is a, also online. It lays out the call for engendering the outcomes of the conference, and pursuing in a more deliberate way, all the obligations we have, for example, in the SDG Number five (5) in the SDG's. And then came the full regular meeting for four (4) days of the Small Island Developing States and you would have already seen in the media, the outcome document there.

Resilient prosperity, pursuit of resilient prosperity for Small Island Developing States, all our sisters and brother and they attending in large numbers from, you know the Pacific, all the Pacific Islands, the African Island, the islands in the Indian Ocean, the islands in the South China seas. So it was a... and of course the Caribbean Islands. So we were able to put the case of the threats of Caribbean, of Small Island States to the International Community, and I think the executive branch of government here in Grenada, will report on its bilaterals and what was accomplished and how it perceived it. I simply want to say, for us as Parliamentarians, it's important to follow these matters, because eventually, legislation will be needed to scale up the kinds of development, sustainable development agenda that is called for in these outcome documents.

So greater familiarity with the process and the content of these outcomes could make a difference. And in my case I was, you know, able to... I was invited to, to moderate meeting, to serve on panels and to be a part of this... It was my third of four (4) meetings, having attended the very first one, as a civil society activist in 1994 in Barbados and then in Samoa and here in Antigua. So it's, it's a category in the international community to which Grenada has also provided some leadership, but to which it belongs. And I just take to your attention.

May I also thank Senator Salim Rahaman for so ably representing Grenada on the CPA Caribbean Branch, the Executive Committee, as the Executive Branch of the Caribbean CPA is revisiting its Constitution. And I gathered Senator Rahaman from participants that you brought a refreshing perspective and I'm thankful to you for doing that. Grenada is on the Executive of the Caribbean CPA and it is important for us to attend all the meetings that are held.

We also have had meetings with the ParlAmericas, Grenada is a Vice President of ParlAmericas twice now, last year and then this year. Last year was myself of the year before, but this year our Speaker also became a Vice President, so we are called on, both at the regional CPA and at the ParlAmericas we are called on to provide leadership, to be present, and it's a wide range of topics that are discussed, almost in parallel with the executive, issues of artificial intelligence, issues of climate change and the legislation concerning that, particularly around energy transition. It's expected that Parliamentarians will be hospitable to those initiatives. And so, I encourage you to pay attention.

Lastly, I want to report that Senator Claudette Joseph is out of state on government business and has sent her apologies. Likewise Senator Neilon Franklyn, also is out of state and has asked to be excused. Here ends my updates. Thank you.”
