### **MOTION TO CELEBRATE THE LIFE OF THE LATE SIR DANIEL WILLIAMS, GCMG, QC, FORMER GOVERNOR-GENERAL OF GRENADA.**

**WHEREAS** former Governor-General, His Excellency, Sir Daniel Williams, Knight Grand Cross of the Most Distinguished Order of St. Michael and St. George, and Queens Counsel passed away on October 2, 2024.

**AND WHEREAS** His Excellency, Sir Daniel Williams, served as a Parliamentarian representing the Constituency of St. David and was a Minister of Government from 1984 to 1989.

**AND WHEREAS** His Excellency, Sir Daniel Williams, served the State of Grenada as Governor-General from 1996 to 2008 with unwavering dedication and a well-formed disposition of integrity;

**AND WHEREAS** His Excellency, Sir Daniel Williams, was an exceptional leader and an outstanding gatekeeper of the public interest, steadfastly upholding the values of democracy, justice, and good governance;

**AND WHEREAS** His Excellency, Sir Daniel Williams, was a paragon of virtue whose contributions far surpassed the ceremonial role of his Office, tirelessly promoting unity and stability in the interest of the State of Grenada;

**AND WHEREAS** the Members of the Senate and of the House of Representatives assembled at a Special Sitting of both Houses of Parliament, are desirous of honouring and paying their respects to the *late* Sir Daniel Williams for his esteemed Public Service, for nurturing the highest principles and practices while in the Service of the State of Grenada;

**NOW THEREFORE BE IT RESOLVED THAT** this Special Joint Sitting of the Houses of Parliament held at Mt. Wheldale, St. George, this 15<sup>th</sup> Day of October 2024, hereby recognize the substantial contributions made by His Excellency, Sir Daniel Williams, as a resolute Governor-General and an exemplar of erudite principles, respected and acknowledged throughout Grenada, regionally and extra regionally;

Madam President adjourned the Senate Sine Die.


