Should you fail to report for duty *on or before 22nd August 2025*, as instructed, the Commission will regard you as having abandoned your office with effect from 1st April, 2025, in accordance with the Provisions of Regulation 41 (1) of the Public Service Commission Regulations SR&O No. 27 of 1969.

## CONSUMER PRICE INDEX (JAN 2010 =100)

MAY 2025

The CPI is compiled at two levels. The first level uses an equally-weighted geometric mean (Jevons) index in which the price relative is derived as a geometric average of 198 items, containing 1102 varieties obtained from 193 outlets.

In the second level, the weights are applied to derive the weighted geometric aggregate (Cobb-Douglas) index. The weights represent the pattern of consumers' expenditure for Grenada, derived from the Household Income and Expenditure Survey conducted over the period October 2007 – February 2008.

The above table shows the Consumer Price Index for the months of May 2025, April 2025, and the corresponding months of the last two years: May 2024 and May 2023, for comparison. The overall index moved from 120.70 index points in April 2025 to 119.96 index points in May 2025 representing a decrease of 0.61%. An examination of the various groups shows the following:

Price decreases were recorded in the groupings: **"Housing, Water, Electricity, Gas and Other Fuels"** (0.28%), **"Transport"**, and **"Miscellaneous Goods and Services"** (0.81%), and (8.22%), respectively, resulting from price decreases of: The One Hundred Pound Cylinder of Cooking Gas (4.60%), Motor Vehicle Fuel (4.59%), and Personal Care Products (18.43%).

Despite the overall decrease in the index, the following groupings recorded an increase: **"Food and Non-Alcoholic Beverages"** (0.05%), **"Alcohol Beverages and Tobacco"** (0.06%), **"Furnishing, Household Equipment and Routine Household Maintenance"** (0.07%), and **"Health"** (0.01%). These increases are as a result of a rise in the price of: Rice (0.34%), Pasta Products (0.16%), Beef (0.38%), Poultry (0.15%), Deli Meat (0.15%), Preserved Fish (0.32%), Milk (0.20%), Cheese (0.02%), Edible oils (0.36%), Fresh Fruits (1.50%), Frozen Vegetables (0.02%), Jams and Honey (0.23%), Other Food Products (0.10%), Fruit Juices (0.06%), Rum (0.15%), Beer (0.09%), Non-durable Household Goods (0.16%), and Pharmaceutical Products (0.01%).

The other groupings remained relatively constant.

When compared to the corresponding month of last year, May 2024, the index moved from 120.06 index points to 119.96 index points in May 2025, recording a decrease of 0.08%. This fall is attributed to decreases in the groupings: **"Housing, Water, Electricity, Gas and Other Fuels"** (0.62%) and **"Miscellaneous Goods and Services"** (10.80%), due to a drop in the price of Materials for the Repair of Dwelling (0.53%), Electricity (2.50%), The One Hundred Pound Cylinder of Cooking Gas (7.44%), and Personal Care Products (24.28%).

On the other hand, the following groupings recorded increases: **"Food and Non-Alcoholic Beverages"** (1.28%), **"Alcohol Beverages and Tobacco"** (1.34%), **"Clothing and Footwear"** (1.61%), **"Furnishing, Household Equipment and Routine Household Maintenance"** (0.39%), **"Health"** (1.44%), **"Transport"** (0.50%), **"Communication"** (0.13%), **"Recreation and Culture"** (0.04%), **"Education"** (1.26%), and **"Restaurant and Hotels"** (6.85%). These increases resulted from a rise in the following items: Rice (10.34%), Cereals and Other Products (0.25%), Bread (0.13%), Beef (4.08%), Pork (1.71%), Mutton (5.02%), Poultry (0.76%), Deli Meats (0.55%), Fresh Fish (0.08%), Preserved Fish (1.17%), Milk (0.80%), Cheese (0.11%), Eggs (1.58%), Butter (2.18%), Margarine (2.34%), Fresh Fruits (17.88%), Preserved Fruits (1.04%), Potatoes (2.97%), Frozen Vegetables (2.73%), Sugar (0.02%), Jams and Honey (2.20%), Other Food Products (1.59%), Coffee, Tea and Cocoa Products (0.49%), Water (5.22%), Soft Drinks (2.04%), Fruit Juices (3.36%), Rum (1.02%), Wine (1.01%), Beer (1.07%), Cigarettes (1.98%), Men's Clothing (0.92%), Children and Infants Clothing (3.28%), Clothing Accessories (2.79%), Men's Footwear (2.29%), Women's Footwear (3.87%), Glassware (0.44%), Major Tools (1.32%), Small Tools (4.52%), Non-durable Household Goods (0.89%), Pharmaceutical Products (0.49%), Medical Services (4.20%), Passenger Transport Services by Air (29.91%), Telephone Services (0.14%), Books (0.26%), Pre-Primary and Primary Education (4.03%), and Restaurant Services (6.85%).

Consequently, the inflation rate for May 2025 is negative 0.61% compared to a rate of 1.45% in May 2024.
