# Madam President made the following announcements:

Madam President welcomed all Senators present and gave excuse of absence for Senator the Honourable Mondy André Lewis, Senator the Honourable Dwight Horsford and the uncertainty of Senator the Honourable Claudette Joseph's attendance.

The President further welcomed all visitors in the House and those online to the 2025 Senate Budget Debate.

Senator the Honourable Claudette Joseph entered into the Chamber and Madam President welcomed her.

On behalf of the Senate Madam President extended best wishes of good health to Dr. the Rt. Honourable Keith Mitchell who felt ill at a public event the night before.

Madam President spoke on Grenada's 51<sup>st</sup> Anniversary of Independence, and on behalf of the Senate she thanked the organizers, the National Celebrations Committee, and the people of Grenada, led by Her Excellency, Dame Cecile La Grenade and the Prime Minister of Grenada, Honourable Dickon Mitchell for their leadership and their positive support of national independence.

Madam President greeted Members, persons in the gallery and persons online.

Budget Debate continued.

The under-mentioned Senators made contributions:

Senator the Honourable Seville Francis.

Madam President made remarks about the Senator's presentation and welcomed the Deputy Speaker of the Grenada House of Representatives, Dr. Clarice Modeste-Curwen.

Senator the Honourable Dr. Myanna Charles.

Senator Francis rose on a Point-of-Clarification and stated the following: "Through you Madam President, I would like the Honourable Member Dr. Senator Charles to please prove to this Honourable House at which point during my speech I mentioned and the Honourable Member said, and I quote, "that the Budget for the Ministry of Youth or for the Youth of Grenada is over budgeted." If that cannot be provided, Madam President, I would like for the Honourable Member to please retract the statement and stop misleading this Honourable House."

Senator Charles continued by saying that was not a Point-of-Clarification and she would not yield and would therefore continue with her debate, if so permitted by the President.

Madam President asked for clarity on the Point-of-Clarification.

Senator Charles repeated the statement she made as follows, "My colleague on the "Other Side" said in a lot of words, that Youth is an area that is over budgeted." Her words, not mine.

Madam President stated that it was a Point-of-Information and inquired whether Dr. Charles stood by her statement.

Senator Charles replied in the affirmative.

Madam President told Dr. Charles to proceed.

Dr. Charles continued with her presentation.

Senator Francis again rose.

Madam President asked her whether she had requested the floor.

Senator Francis replied in the affirmative and stated that she was standing on Point-of-Order and asked that the statement by Senator Charles be retracted since such statement was never uttered during her presentation. Therefore, she would like for the Hansard to be reviewed, so that it can be clarified because she did not wish for the young people of the nation to have the misrepresentation and the misconception that their representative is saying that the reduction in the budget is in fact a good thing.

Madam President noted the request for the Hansard and stated that a reply could be given later following the presentation of Senator Charles, and suggested that it could be dealt with under the adjournment.

Senator Norland Cox rose, and the President acknowledged that she would entertain his information.

Senator Cox stated that it was within the right of any member to request a copy of the Hansard for clarity on any matter, He believed both Members felt correct in their responses, so the Hansard would be able to determinate what was said or what was not said and whether comments would be struck off or maintained.

The Leader of Government's Business, expressed that each Member was listening to both Senators in regards to what was uttered and thought it was up to the President to rule on the matter, and it would be in the best interest to do so before the Senator proceeded with her presentation.

Madam President referenced Standing Orders 35, Interruptions on a Point-of-Order and made the following statement, "Senator Francis is refuting a statement that she is alleged to have made; she is refuting that claim by Senator Charles. I have to be sure that you did not say that to be able to instruct Senator Charles to remove it from her statement, because you did not make it. I don't recall your exact words, I have not seen the Hansard, so if you are confident, if you are repeating that you did not make such a statement then I think it is incumbent on Senator Charles to say she withdraws reference to that statement if you are sure and we are sure that statement was not made by you."

Senator Charles asked that the Hansard be awaited, and when it was reviewed then a decision could be made at that point.

The Leader of Government's Business suggested that the Senate take a five minute recess to verify and clarify the matter and then proceed.

Madam President proposed the adjournment of the Senate and called on Senator Francis, Senator Charles, and the Leader of Government's Business to join her in her office and asked the Clerk to send in the Hansard Report.

Senate adjourned at 11:00 a.m. Senate resumed at 11:40 a.m.

Madam President thanked all the distinguished Members of the Senate, members of the public, and school children for their patience and thanked the Hansard team for producing the written record. She welcomed the school children to the debate on the Estimates and also welcomed the Leader of the Opposition, MP Emmalin Pierre and called on Senator Charles to take the floor.

Senator Charles thanked Madam President for her consultation and stated that it was her interpretation that her colleague on the "Other Side" said," in a lot of words that youth is an area that is over budgeted, over budgeted to make an excuse for the harsh blow we see in the 2025 budget" and expressed that the facts were there and continued with her presentation.

Senator Francis again rose and stated that she was not standing to disrupt the Honourable Member for disruption's sake, but on a Point-of-Order, and based on the consultation, the agreement was for the statement to be retracted before proceeding, however, a new statement was made, but no retraction of the old statement.

Madam President called on Senator Charles and stated that was the agreement.

Senator Charles stated that it was her understanding that the agreement was to clarify the statement and to state her interpretation of the statement, which was her understanding, and that was agreed on.

Madam President stated it was based on the statement being retracted by the Senator.

Senator Charles again reiterated that it was her understanding that an agreement was made to reformulate, not retract, which was discussed.

There were conversations from both sides of the table.

The President called for order, called on Senator Francis and asked her to state her response openly.

Senator Francis stated the following, "that from the first time she stood, she asked that the statement be retracted and the fact that they went into a private session to discuss and consult, she would not agree for anything less. Therefore, the agreement was that the statement be reformulated to reflect her interpretation, which is fine. However, the statement previously made that is being reformulated must be retracted in order for the new statement to take precedence and to have meaning."

Madam President called on Senator Charles and asked her to approach the Chair before she spoke.

Madam President and Senator Charles conversed privately.

Senator Charles returned to her place and was offered the floor by the President. The Senator thanked the President for her guidance on the matter and stated that the reformulation that she stated retracted what was said earlier which read "I would like to clarify that it was my interpretation that my colleague on the "Other Side' said in a lot of words that youth is an area that was over budgeted to make an excuse for the harsh blow received in the 2025 budget." She continued her presentation.

Madam President thanked the Senator for her presentation.

Budget Debate continued.

Senator the Honourable David Evlyn Andrew, Minister of Education

Madam President sought clarity from Senator Andrew on whether the sum spoken about was for the victims of Beryl only or whether it was for across the education system.

The Senator replied that it was a response to support families in Carriacou and Petite Martinique who sent their children to continue their education in Grenada at TAMCC.

Madam President thanked Senator Andrew for his presentation and proposed that the Senate break for lunch. The President also thanked Senator Charles for her retraction and her continuation, and thanked Senator Francis for her participation in the consultations with dignity and grace and for her props.

Madam President stated that because the sitting was a little behind schedule, she asked Senator Joseph to allow Senator Lewis to start after lunch.

Senator Dwight Horsford expressed that he had indicated to the Senators that surrounded him that he would like to go first after lunch.

Madam President thanked all for their presence and adjourned for lunch.

Adjourned for lunch at 1:10 p.m. Resumed at 2:30 p.m.
