

**RESOLUTION FOR THE PURPOSES OF SECTION 73 OF THE PUBLIC
SECTOR EMPLOYEES (PENSION FUND) ACT NO. 19 OF 2024**

WHEREAS it is provided by Section 73 of the Public Sector Employees (Pension Fund) Act No. 19 of 2024 (hereinafter referred to as “the Act”) that the Minister may by Order, subject to affirmative resolution, amend the Schedules to the Act;

WHEREAS by virtue of section 26 (3) of the Interpretation and General Provisions Act, the requirement that rules or regulations, or other subsidiary legislation be subject to affirmative resolution means that such rules or regulations or other subsidiary legislation shall not come into effect after having been duly made by the appropriate authority unless and until they have been approved by a resolution of the House of Representatives and, after having been so approved they have then been published in the *Gazette*;

WHEREAS the Minister proposes to amend Schedule I of the Act to insert the names of statutory bodies that have officially expressed interest in signing onto the Public Sector Employees Pension Scheme, established in accordance with section 5 of the Act;

WHEREAS the Minister has exercised his powers to make an Order under section 73 of the Act;

AND WHEREAS it is expedient that the Public Sector Employees (Pension Fund) (Amendment of Schedule I) (No. 2) Order, 2025 which seeks to amend Schedule I to the Act, be approved by the House of Representatives;

NOW THEREFORE BE IT RESOLVED that pursuant to section 73 of the Act, the Public Sector Employees (Pension Fund) (Amendment of Schedule I) (No. 2) Order, 2025, as set out in the Schedule to this Resolution is hereby approved by the House of Representatives.

Citation

1. This Order may be cited as the—

Definition

2. In this Order, “principal Act” means the Public Sector Employees (Pension Fund) Act No. 19 of 2024.

Amendment of Schedule I of the principal Act

3. Schedule I of the principal Act is amended by inserting after Item 5, the following new Items—

- “6. Grenada Cultural Foundation
7. Grenada National Stadium Authority
8. Planning and Development Authority
9. T.A. Marryshow Community College
10. Grenada Solid Waste Management Authority
11. National Training Agency”.

Revocation of Public Sector Employees (Pension Fund) (Amendment of Schedule I) Order, 2025

4. The Public Sector Employees (Pension Fund) (Amendment of Schedule I) Order, 2025, SR&O No. 30 of 2025, is hereby revoked.
