GRENADA

ACT NO. OF 2026

AN ACT to appropriate an additional sum of Three Hundred and Ten Million, Nine Hundred and Twenty-One Thousand, Six Hundred and Thirty-Three Dollars (\$310,921,633.00) to the service of the State of Grenada for the fiscal year 1st January to 31st December 2026.

BE IT ENACTED by the King's Most Excellent Majesty, by and with the advice and consent of the Senate and the House of Representatives, and by the authority of the same as follows—

Short title

1. This Act may be cited as the

SUPPLEMENTARY APPROPRIATION ACT, 2026.

Appropriation

2. (1) There may be issued from the Consolidated Fund and applied to the service of the State of Grenada for the fiscal year 1st January to 31st December 2026, an additional sum not exceeding Three Hundred and Ten Million, Nine Hundred and Twenty-One Thousand, Six Hundred and Thirty-Three Dollars (\$310,921,633.00) in addition to the sums already appropriated for that fiscal year.

- (2) The sum mentioned in subsection (1) is appropriated for the purposes specified in the Schedule.
